**Nama dan permulaan kuat kuasa**

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Pendaftaran Jurutera (Pindaan) 2021**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 Januari 2022.


2. Peraturan-Peraturan Pendaftaran Jurutera 1990 [P.U. (A) 128/1990] dipinda dalam subperaturan (1)—

REGISTRATION OF ENGINEERS ACT 1967

REGISTRATION OF ENGINEERS (AMENDMENT) REGULATIONS 2021

IN exercise of the powers conferred by section 26 of the Registration of Engineers Act 1967 [Act 138], the Board, with the approval of the Minister, makes the following regulations:

**Citation and commencement**

1. (1) These regulations may be cited as the **Registration of Engineers (Amendment) Regulations 2021**.

(2) These Regulations come into operation on 1 January 2022.

**Amendment of regulation 34A**


3. The Registration of Engineers Regulations 1990 [P.U. (A) 128/1990] are amended in subregulation (1)—

(a) in paragraph (a), by inserting after the words “fifty thousand ringgit,” the word “and”;


(b) by deleting paragraph (b); and

(c) in paragraph (c), by deleting the word “remaining”.
